By the year 2000, Autodesk had grown to more than 10,000 employees, with AutoCAD Activation Code installed on more than 100 million personal computers. As of December 2013, more than 200 million AutoCAD Crack drawings had been created. AutoCAD Features The menu system is divided into two categories:

- Professional (version 2017 and later) menus
- Base (version 2018 and earlier) menus

Many common commands from earlier AutoCAD versions are still available in the Professional menu; however, new menus have been added to make the menus more intuitive and easier to use. For example, in early versions of AutoCAD, the command "Select All" had no subcommand. The user had to go to a separate command called Select All Objects. In 2017, the Command Select All Objects was moved to the Merge and Segment menu, under Select. Similarly, the command Merge to Union was not in the command set. In 2017, it moved to the Edit > Merge and Segment > Merge to Union menu. As with other AutoCAD features, there is an update schedule for AutoCAD. Updates to the AutoCAD program itself are made every three months. Updates to AutoCAD features are made every six months. AutoCAD 2018 for Windows is currently scheduled for an update in the first quarter of 2019. In addition to the standard and Professional menus, there are also several other menu categories, including Windows, User Preferences, Object, Preferences, Documents, Media, System, and Help. The Windows menu provides access to the Windows shell (files, folders, and other system data). The User Preferences menu allows you to customize AutoCAD to suit your preferences. The Object menu has commands for creating a command button or menu in the ribbon and for converting a drawing into an AutoCAD text (.txt) file, or writing out a drawing to a file. The Preferences menu contains commands for making AutoCAD start up, shutdown, and shut down other applications. The Documents menu has commands for opening, saving, exporting, and printing drawings. The Media menu contains commands for managing AutoCAD images, movies, sound, and color. The System menu has commands for system information and the maintenance and troubleshooting of AutoCAD. The Help menu provides access to
