Field of the Invention This invention relates to a charge control material for electrophotographic photoreceptors, a photoreceptor, and a process cartridge and an electrophotographic apparatus using the photoreceptor, b. Description of the Related Art Electrophotographic photoreceptors include ones having inorganic photosensitive layers containing inorganic materials such as selenium, cadmium sulfide, zinc oxide, and the like.
